Background: East Grand Rapids Public Schools has participated in the Kent Intermediate School District

Collaborative Schools of Choice Program since the inception in the 1996-1997 school year. The Finance/Facilities Committee and Superintendent are recommending that we accept <u>41</u> students

through the 2020-2021 Kent ISD Collaborative Schools of Choice Program.

## 11. Approval of High School PAC EIFS Repair Bid- Anthony Morey (Enclosure #11)

Background: Per Board Policy #3610, the District shall obtain a minimum of two informal bids for any service or

single-item purchase that exceeds 50% of the Competitive Bid Threshold established by the State annually. All potential expenditures covered under this guideline must be submitted to the Board, with an explanation for the recommended selection, for approval prior to incurring the cost. The District received three bids for the High School PAC EIFS Repairs due to water intrusion through EIFS walls.

Recommendation: The Assistant Superintendent of Finance and Operations recommends contracting with ISC

Restoration Inc. to complete the necessary repairs to the EIFS section of the High School Performing Arts Center at a total cost of \$22,500. The Finance/Facilities Committee reviewed the bids and

recommends bid approval.

# 12. Approval of Storage Area Network (SAN) and Uninterruptible Power Supply (UPS) Bids- Anthony Morey

(Enclosure #12)

Background: Per Board Policy #3610, the District shall obtain a minimum of two informal bids for any service or

single-item purchase that exceeds 50% of the Competitive Bid Threshold established by the State annually. All potential expenditures covered under this guideline must be submitted to the Board, with an explanation for the recommended selection, for approval prior to incurring the cost. The District received three bids for Storage Area Network (SAN), and the Uninterruptible Power Supply (UPS) will be acquired from a vendor participating in the cooperative purchasing program operated by the

Michigan Department of Management and Budget.

Recommendation: The Assistant Superintendent of Finance and Operations, and Director of Technology and Assessment

recommend purchasing a Hewlett Packard Nimble Storage Area Array installation from Trace3-Grand Rapids for \$84,672.96, as well as purchasing a Liebert Uninterruptible Power Supply from Hedrick-Grand Rapids for \$21,866. The total cost of these two items combined is \$106,538.96. The

Finance/Facilities Committee reviewed the bids and recommends bid approval.
